**1. Price, Fees & Shipping Date:**

**Payments, Fees and Deposits are non-refundable.** They may, at the sole discretion of the stud owner, be applied to a future stud service of the same stud, or may, at the sole discretion of the stud owner, be applied to a future stud service of another of the stud owners' males (for the same Dame).

\*Pick of the litter is defined as the first pick of the litter without reservation and must be a healthy puppy without health or genetic related issues as determined by a licensed Veterinarian. The stud provider has 3 days after taking possession to have the puppy examined by a licensed Veterinarian. Should the puppy be found with a health or genetic related defect the dame provider shall all the exchange for another pup of the Stud providers choosing. If no suitable puppies are available, the Dame provider agrees to pay the Stud provider the average price of the sale of the puppies from the litter

**2. Terms & Conditions:**

**a. Stud Provider:**

- i. That the stud is proven, meaning that he has successfully sired one or more litters.
- ii. Will sign the litter registration promptly (once all stud fees have been paid in full)
- iii. Will provide one **(1)** repeat breeding to the same dame should the breeding be <sup>2</sup>unsuccessful or the litter results in a single pup.
- iv. The Stud Provider shall not be responsible for any fees or actions outside of, or beyond that of providing the Semen Specimen

**b. Dame Owner:**

- i. The dame has a <sup>1</sup>positive progesterone test and acceptable AI date has been confirmed and approved by a licensed veterinarian.
- ii. Shall provide proof of the progesterone levels, from a licensed Veterinarian or Home progesterone analyzer prior to the breeding.
- iii. Provide a statement from a licensed veterinarian that a pregnancy did not result within 70 days from the AI date to qualify for a re-breeding outlined above.
- iv. Keep the dame properly confined following the breeding to ensure no other male can mate with her until her mating season is complete.
- v. Provide the date of birth and number of puppies within 2 days of birth.
- vi. **assumes all risks and shall be responsible for all damages, injuries or illnesses should any occur during the breeding / AI process.**

# Breeding Agreement

<sup>1</sup> A positive progesterone is defined as a test result in which a veterinarian confirms that the range is within acceptable limits / ideal for AI on the planned AI date; as defined and published by the Analyzers Manufacturer.

<sup>2</sup> Unsuccessful breeding requires the AI be performed by an experienced and conformation of a progesterone level conducive for a successful AI.

### 3. General:

The Stud Provider shall not be responsible for any fees or actions outside of, or beyond that of providing stud for AI purposes. The Dame owner **assumes all risks and shall be responsible for any and all damages or injuries should any occur during the breeding / AI process.** The Dame owner shall, in the event of an aggressive Dame, be responsible for ensuring the proper precautions are taken to protect both the Stud and the Dame. The Dame owner shall be responsible for any injuries inflicted on the Stud by the Dame.

When AI's are performed in the absence of a positive progesterone test, or when progesterone levels are outside the acceptable limits for performing an AI (per the device manufacturer), the stud owner is not required to offer a free re-breeding.

Unless otherwise agreed to, AI's may be performed using either a fresh specimen or chilled sample.

**Should the Dame owner not coordinate, miss, or otherwise fail to meet at the agreed to date and time, the deposit shall not be returned. The Stud Provider shall make a good effort gesture to accommodate a new date / appointment for the same dame, as long as, the timing aligns with optimal breeding progesterone levels.**
